

# The AO Principles of fracture management

Fracture reduction and fixation to restore anatomical relationships.

Early and safe mobilization and rehabilitation of the injured part and the patient as a whole.



Fracture fixation providing absolute or relative stability, as required by the "personality" of the fracture, the patient, and the injury.

Preservation of the blood supply to soft tissues and bone by gentle reduction techniques and careful handling.

## Course objectives

This course is an instructional course with the objective to provide doctors and other healthcare professionals with guidelines for basic nonoperative treatment of common fractures and to enable them to recognize those fractures that need operative treatment in a specialist unit.

## Structure of the course

- Presentations
- Practical exercises
- Group discussions

### Content

This course will address:

- Functional Anatomy of the hand
- Overview of hand fractures and tendon injuries
- Assessement and pronciples of management of the injured hand
- Hands-on exercises on safe splinting of hand, extensor tendon repair

By the end of the course participants will be able to

- Describe the functional anatomy of the hand
- Do systematic assessment of the injured hand
- Describe the basic principles for hand injuries management
- Identify injuries that would better be treated at a Tertiary facility
- Safe and appropriate splinting of the injured hand
- Formulate systems for maintaining safe standards of practice
